Section V. Requirements and Conditions

- A. Work area to be marked out in the field in WHITE PAINT
- B. Final restoration dimensions to be determined by Department of Public Works
- C. Temporary pavement shall be placed in all trenches not using control density fill
- D. Open trenches must be properly covered with adequate sized steel plates every night to the satisfaction of the Department of Public Works
- E. A minimum of 24 hours notice must be given to the Department of Public Works prior to the start of any work

Section VI. Additional Requirements for Sewers and Water

- A. Sewer main to be inspected by Department of Public Works prior to connection
 - B. A sewer pipe saddle must be used to connect laterals to the sewer main
 - C. Department of Public Works must inspect lateral connection prior to placement of concrete or backfill
- No stormwater connections allowed to the sanitary sewer (sump pumps, leaders, trench drains, etc.)
Sewer or drain connection may be Smoke Tested or Dye Tested**

Section VII. Insurance Requirements

The application shall also be accompanied by a certificate of insurance, with the Village of Medina named as an added insured. Unless otherwise required by special specifications, each policy shall have limits of not less than the following:

Bodily Injury Liability

Single Limit
\$1,000,000 each person
\$1,000,000 each occurrence

Property Damage Liability

Single limit
\$1,000,000 each occurrence

The following endorsement must be read, understood.

“It is agreed that the liability insurance policy submitted for this permit insures the Village of Medina, its officers, servants and agents against any liability within the limits hereof, for personal injury or property damage, directly or indirectly resulting from or arising out of the granting by the Village of Medina a permit for work within a right-of-way to:
