Perry reported that his department would begin the milling process prior to paving the following streets – Elm Street, portions of Ohio and Eagle Streets and West Center Street from Prospect Avenue to Salt Works Road. Supt. Perry said that they had been fixing manholes and valve boxes, trimming trees and grinding out tree stumps. He also reported that the recent auction of surplus equipment and other items had earned \$40,119, almost \$20,000 over budgeted revenue.

Police Chief Kenward referred to the Computer System Upgrade specifications sheet attached to his monthly report. He said that Spectrum had already installed the dedicated COAX line into the Police Department in anticipation of the upgrade.

Fire Chief Lupo reported that Captain Jackson has received his Fire Officer 2 credentials after a week-long training at the Fire Academy. He reported on two recent fires and the status of ambulance calls as pertains to COVA and mutual aid responses. He also reported that the suburban purchased with a DASNY grant is ready for delivery. He said that Ambulance 61 was returned to Gorman for a repair on the suspension.

The Mayor recognized Kathy Blackburn who commented that the flowers on Main Street looked great and she wished to express her thanks to the DPW for watering.

A motion was made by Trustee Toale and seconded by Trustee Bensley. The meeting is adjourned at 8:40 p.m.
