MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF MEDINA HELD ON MONDAY, JUNE 22, 2020 AT 6:30 P.M. IN THE TOWN OF SHELBY TOWN HALL.

Mayor Sidari opened workshop discussions at 6:30 p.m. requesting reports from Department Heads.

Supt. Perry reported that his department had poured the sidewalk for the splash pad in Pine Street Park, patched potholes, planted twenty trees at various places in the Village, painted the caretakers house at Boxwood Cemetery, installed the STOP signs as per the recently adopted Local Law, assisted the Town of Ridgeway in repairing a water line, repaired several street signs and began milling roads that are due to be paved.

Police Chief Kenward reported that Clayton Smith received medical clearance from Civil Service and would be participating in field training. He also said that his department had assisted with Black Lives Matter protests here and in the City of Batavia. He said that they have been very busy with continuous complaints regarding fireworks throughout the Village. He acknowledged Officer Reeves and MFD members for their efforts in saving a drowning child in a local pool. He also reported that the new patrol car was in service.

Fire Chief Jackson reported that FF Tyler Harrington would continue in-person training at the Fire Academy on June 29. Bob Urtel and Sergio DiCenso have given two-week notices taking lateral transfers to the City of Lockport and Bob Urtel requests to remain in the Department as a Callman. This leaves three vacancies and the Chief would like to request an Eligible List from Civil Service. Chief Jackson also noted the rescue of the drowning child.

Code Enforcement Officer Gardner submitted his monthly report, noting that he had issued seven building permits in May. He also reported that he had received four requests to have vacant property registry fees removed, all for various reasons. Mrs. Joan Whittier had previously paid VPR fees assessed to five of her properties, but the payment was received a few days following the addition of those fees to her property taxes; the Lee Whedon Library had erroneously been assessed a VPR fee on a parcel they recently purchased; Krzysztof Moskal claimed COVID-19 had prevented them from working on their property and requested an extension; and Noori Bibi indicated that they would be working on their property soon.

Trustee Bensley noted that with the current social climate exploited in the news, it was important to remember the necessity of having a Fire and Police Department to respond to incidents such as the recent near drowning.
