### **Project Description**

Q\_575 Project Description. Concisely describe the project, indicating the location, what will be planned, designed, acquired, and/or constructed, the issues/opportunities to be addressed, and expected outcomes and deliverables. The Town of Urbana, in Steuben County, requests \$945,691 in funding, with a 15% local match of \$166,887 for a total project cost of \$1,112,578 to develop Phase 2 of Curtiss Park. Upon completion, it will connect three local parks with trails throughout the region. It involves connecting to Phase 1 trails, continuation of the trail into a stoned parking lot and additional passive trails along the waterfront, observation tower, and an ADA-compliant kayak launch. The trails will connect the Hammondsport central business district to Curtiss Park, Keuka Lake, Champlin Beach, and the Finger Lakes Trail via the Triad Trail.

The Town only owns 9 miles of waterfront because the lakefront is densely developed, predominantly with private residences, and only about 7% of the lake's shoreline is accessible to the public. To increase the amount of open space and recreational amenities available to residents, and visitors, the Town acquired 7 acres of waterfront property from the Bath & Hammondsport Railroad. The Curtiss Park property, is listed in the New York State Open Space Conservation Plan as a priority conservation project. Completion of this project will conserve 7 acres of open space.

### Q\_976 Statement of Need

The Town of Urbana operates and maintains 18.2 acres of parkland. The primary facility is Champlin Beach Park, which offers limited waterfront access to Keuka Lake. However, due to its location on the southern side of Keuka Lake Inlet, it is not easily accessible by pedestrians in the high-density, residential center of the Urbana/Hammondsport Region. Curtiss Park will create that access. The total cost for this project is \$1,112,578. The Town is committed to providing the required 15% match (\$166,887) for the project through in-kind services and town funds. Due to the environmentally sensitive nature of the project, and the high cost of Phase 2 completion, this project is too large in terms of scale and cost for a town with an estimated population of just 2,404 (as of 2020 Census update) to complete using only local resources.

Q\_2366 How does your project align with the Regional Economic Development Council's Strategic Plan/Upstate Revitalization Initiative Plan? (strategic plans are located at https://regionalcouncils.ny.gov/)

One of the goals laid out in the Finger Lakes Regional Economic Development Council's Strategic Plan is to "Strengthen and support the development of the Finger Lakes' diverse water resources

and recreational tourism opportunities, allowing greater access and promoting year-round use" (p. 18). This project will directly address this goal, allowing for recreational opportunities for people of all abilities, increasing access to Keuka Lake, and promoting tourism in the surrounding area.

Q\_930 Explain what makes your project a regional economic priority - for example creates jobs, economic investment, sustainability and community revitalization, government efficiency or consolidation etc.

Curtiss Park is integral to the area's image and economic niche in the tourism industry, promoting revenue generation and visual appeal by providing visitors and residents with a recreational amenity that is a short walk to a bustling downtown business district. This project will support economic and community revitalization at Keuka Lake, a major tourist attraction in the Southern Tier. Additional trails, parking, kayak lunch will increase waterfront access, connect to Phase 1 improvements, and to downtown Hammondsport and the Finger Lakes Trail. An estimated 10 construction jobs and 1-2 additional town employees will be employed through this project. It will create economic revitalization in the surrounding community, attracting tourists to waterside businesses, bed and breakfasts, water sports, and the newly renovated Curtiss Museum.

The southern end of Keuka Lake does not offer the same amenities as the north end or other Finger Lakes. The Town is filling this void. The Town and Village together encompass approximately 9 miles of shoreline, a tremendous recreational, scenic, environmental, and tourism asset. However, the lakefront is densely developed, predominantly with private residences, and only about 7% of the lake's shoreline is accessible to the public. This project will grant access to the southern Keuka Lake waterfront so that residents and approximately 250,000 tourists to the area each year can experience this beautiful natural resource. Due to the proximity to nearby businesses, they will enjoy the economic revitalization this project will create.

There will be no charge to enjoy this pleasant green space, and as word spreads about the area, the Town anticipates drawing people from the entire WNY Area, including the Cities of Buffalo and Rochester.
